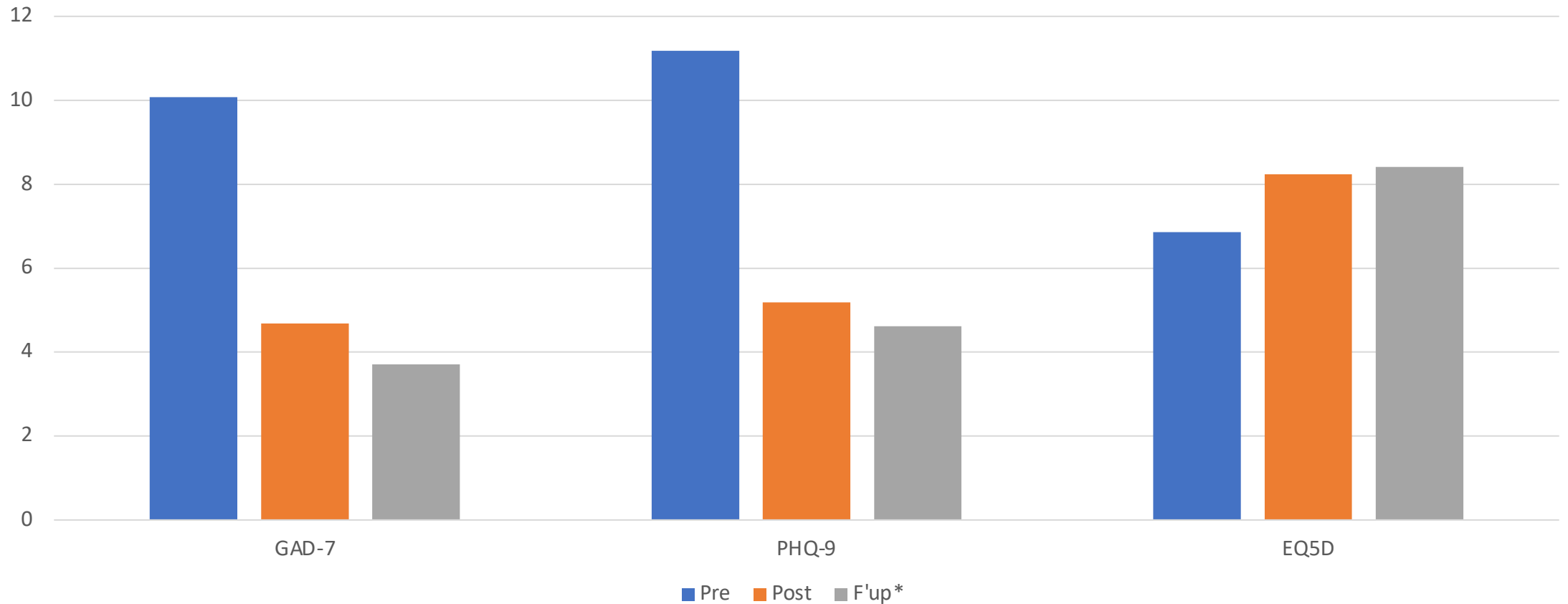

# The overall goal of the project „SOLATIUM”

- Victims and their families overcome harm, caused by war crimes, lead a dignified life and contribute towards reconciliation and peace-building within their communities

This overall goal is achieved by *2 inter-connected programmatic directions*:

1. Victims and their families are offered holistic, bio-psycho-social rehabilitation assistance in order to recover and overcome damage and trauma;
2. Affected communities are strengthened and healing is supported through social cohesion, piece-building and reconciliation activities



# Beneficiaries of the action:

- Persons, displaced or affected by 2008 war, who were tortured, raped, taken as hostages, whose property was destroyed, victims of pillaging, bombardment, military occupation, and other international crimes, established by the Rome Statute and investigated and prosecuted by ICC.
- Family members of the direct beneficiaries (above 15 years old) and members of communities, that are affected by 2008 war actions, including villages subjected to pillaging, bombing, and/or displacement from their residences.
